

### MINUTES OF THE SPECIAL MEETING OF THE LIBRARY BOARD OF TRUSTEES OF THE CICERO PUBLIC LIBRARY HELD AT THE CICERO PUBLIC LIBRARY ON MONDAY, AUGUST 28, 2023 5:00 P.M.

President Vargas called the meeting to order at 5:10 p.m.

### Roll Call

Secretary Mary Hernandez called roll. The following Trustees were present: President Ismael Vargas, Trustees Rosemarie Esposito, Mario Castaneda and Secretary Mary Hernandez. Absent: Vice-President Anthony Grazzini and Trustee Alfonso Vega. Also present were Library Director Sandra Tomschin, Board Attorney Matt Byrne and Recording Secretary Maria Salinas.

The Pledge of Allegiance was recited.

#### **Unfinished Business**

July 2, 2023, Flood Event – Update

Library Director Sandra Tomschin updated the Trustees of the emergency repairs needed on the roof and the flooding in the basement as a result of the losses incurred by the library due to the flood of July 2, 2023.

Trustee Alfonso Vega arrived at 5:12 p.m.

Library Director Sandra Tomschin noted that the roof was repaired, however, after another rainstorm, there was still leaking coming from the roof. She disseminated pictures of the drain pipe that is rusted and corroded and said this was the source of the leak. She indicated that the contractor for the roof noted that a plumber would need to do the repair on the drain pipe. She indicated that the plumber did access the drain pipe and noted that it would need to be replaced, along with other internal plumbing pipes. She noted that with the repairs, it would prevent the leak and the basement from being flooded.



Secretary Hernandez made a motion to approve the emergency repairs due to the flood as presented. Trustee Castaneda seconded the motion. Roll call: All Trustees present voting aye: President Vargas, Trustees Esposito Castaneda, Vega and Secretary Hernandez. Nays: None. Absent: Vice-President Grazzini. Motion carried.
