

MINUTES OF THE REGULAR MEETING OF THE LIBRARY BOARD OF TRUSTEES OF THE CICERO PUBLIC LIBRARY HELD AT THE CICERO PUBLIC LIBRARY ON MONDAY, FEBRUARY 10, 2025 5:00 P.M.

Technology Grant

- Our iMac is being configured for computer lab usage and should be available soon.
- We purchased a 6-piece self-check-out station, that is also being configured for use and should be ready soon.
- Once the equipment is ready, the Trustees will be invited for pictures.



2025 Goals

Library Director Tomschin set some goals for 2025, including, but not limited to:

- Finalizing the updates to all the library's policies and procedures.
- Procuring a new website to integrate with our new calendar and offer 24/7 access to library materials. Update the webpage to make it more user friendly, better organized and something to be proud of.
- Updated furniture for the Youth Services Department.
- Library Director Tomschin has been very careful with spending since her arrival and there should be funds available to remodel and install a combination/multipurpose room, with autism features that can be utilized when needed. This would close the current playroom to make the Youth Services Department more inviting to those not participating in activities in the play area.
- Replace the statue on the corner that was stolen with either a new statue or a monumental sign of the library.
- Fully staff the Reference and Circulation Departments and work on a dedicated social media and website role.

- We are happy to bring back movie night at the library and excited to bring back our popular Garden Club and Seed Sharing library.
- We will continue to find additional programming to fill the needs of our public demands.

The appointment, employment, compensation, discipline, performance, or dismissal of specific employees, specific individuals who serve as independent contractors in a park, recreational, or educational setting, or specific volunteers of the public body or legal counsel for the public body, including hearing testimony on a complaint lodged against an employee, a specific individual who serves as an independent contractor in a park, recreational, or educational setting or a volunteer of the public body or against legal counsel for the public body to determine its validity. However, a meeting to consider an increase in compensation to a specific employee that is subject to the Local Government Wage Increase Transparency Act may not be closed and must be open to the public. 5 ILCS 120/2 (c)(1).

Litigation, when an action against, affecting or on behalf of the particular public body has been filed and is pending before a court or administrative tribunal, or when the public body finds that an action is probable or imminent, in which case the basis for the finding shall be recorded and entered into the minutes of the closed meeting. 5 ILCS 120/2(c) (11).
