Library Director Sandra Tomschin reported the following updates.

### Administrative

- Work continued with Library Market with the new redesign of the Library's website.
- Illinois Public Library Annual Report (IPLAR) and the Illinois Statistical Survey have been completed and submitted. She thanked the department heads for helping track and compiling of all the statistics needed for these reports.
- "Project Next Generation" grant was awarded and the agreement was executed and submitted to the state. Cristian applied for a "shark tank" like program that utilizes Makerspace, which allows the students to create, design and market their product. Congratulations to Cristian on obtaining these funds in the amount of \$12,557.00.
- Library is still in the running for the state's expanded equalization grant and will keep the Trustees posted on the status.
- A meeting is planned with the town's Finance Department regarding the 2026 budget. It is pending approval at the town's level and anticipated for review and approval at the next meeting in April 2026.
- The EV Charging Station has been installed. The Ribbon Cutting event is scheduled for April 21, 2026, at 9:30 a.m.

### Programs

- We continue to attend Unify Fridays at Unity Junior High School.
- A big addition to the library is 2 turtles! Linda's brother generously donated these wonderful turtles to the Youth Services Department. They are a huge hit and a contest is underway to name them.
- Garden Club programming has kicked off! Every month there will be a different gardening topic. This interest of this club has continued and grown over the last few years.
- We continue to find additional programming to fill the need of our public demands.
